K&K Charity Sponsorship Scheme 2018

Application Guidelines

“Dare to DREAM” - K&K Charity Sponsorship Scheme is a sponsorship scheme for innovative projects that focus on

- Children or youth education
- Developmental needs of youth

Eligible Applicants

The applicants must be charitable institutions operating in Hong Kong and established:

- i) established by the Hong Kong legislature; or
- ii) incorporated under the Companies Registry (Cap 622); or
- iii) under the Societies Ordinance (Cap. 151); or
- iv) registered on the list of approved charitable institutions or trusts of a public character, being exempt from tax under Section 88 of the Inland Revenue Ordinance (Cap 112).

Maximum Grants

Each proposed project can be granted for a maximum of HK\$200,000. Prior exemption may be granted by the Charity upon requests with reasons stated.

Selection Criteria

- ✓ Innovative and feasibility of the community project;
 - ✓ Preference will be given to projects that have not received funding from the government or any other funding organization;
 - ✓ Sustainability of the project;
 - ✓ Track record of the applicant in providing the proposed or similar services;
 - ✓ Potential to leverage the employee volunteers of K&K Property;
 - ✓ Well-established evaluation for the effectiveness of the project;
 - ✓ Use of funds in appropriate and cost-effective manner.

- ✗ Proposals seeking funding for the operating costs, conferences, annual meetings, endowments, researches, advertising campaigns and fundraising projects will not be considered.
 - ✗ Projects that have sole or dominant purpose of promoting political event/campaign or specific religious event will not be considered.

Remarks

Proposals that include requests for project-related administrative costs will only be considered if the administrative costs account for no more than 5% of the funding requested.

Application method and Important Dates

For eligible and interested organisations, please upload the completed application form through the charity website www.kkcharity.org or email to info@kkcharity.org or by post to Office No. 805-806, 8th Floor, Man Yee Building, No. 68 Des Voeux Road Central, Central, Hong Kong, Attn. to 'K&K Charity Limited' on or before 28th July, 2018. Late submission will not be considered. For applications by post, the date on the postal chop will be taken as the date of application.

Deadline for application	28 th July, 2018
Review and Interviews	30 th July to 10 th August, 2018
Result Release	13 th - 17 th August, 2018
Project Commencement Period	1 st September, 2018 to 30 th June, 2019
Deadline for evaluation report	30 th July, 2019 or 1 month after the end of project, whichever is earlier
